# 7. Planning Applications

2023/2074/OUT - Application for Outline Planning Permission with some matters reserved for up to 9no. dwellinghouses with details of access. Land To the East of Edford Hill, Holcombe, Radstock

Cllr Brand gave a brief outline of the planning application. He introduced the applicant and his agent who explained that the application was for outline planning for up to 9 houses, 2 of which would be sold as affordable housing (20% less than the market price).

An ecological assessment had been completed which showed that as the land had been grazed by horses for some time, it was of low ecological value. The hedges will remain untouched and a 15m buffer would be created between the development and the boundary fence at the top of the site enhancing the ecological status of the area. It was claimed that the development would have a positive net gain on bio-diversity. An odour assessment had also been completed which showed there would be no adverse effect from the development.

Members of the public raised the following concerns:

- How did they know that there was a demand for housing in the village.
- The site was outside the village development boundary.
- The entrance road would be a concern due to the volume of traffic and pedestrians.
- Drainage and flooding could be an issue.
- The sewers may be unable to cope with the addition of these houses.

The Agent explained that Somerset Council are not currently able to show a 5 years housing supply meaning that there is a shortage of housing. Wessex Water would comment on the sewers and the applicant also owns the neighbouring land and would be able to mitigate and resolve any potential flooding issues.

After listening to the concerns raised by members of the public, the councillors reviewed the evidence and considered whether to approve the application. Cllr Brand proposed that the application should be approved. No other Councillors wished to second the proposal and a vote was taken to recommend refusal on the basis that the application site was outside the village development boundary and that there was a Highways safety concern around the entrance / exit on to Holcombe Hill which is busy with vehicles and pedestrians.
